Terms of Trade

- Accounts are payable by the 20th of the month following the date of invoice **unless** otherwise specified in your account confirmation letter. If the account is not paid within 30 days after the due date, our collection agent may charge you a fee (minimal \$25), equal to 25% of the unpaid portion of the account. Where the total debt collection agency costs, legal and other costs arising from the collection of any amount owing exceeds the debt collection fee charged, our debt collection agent is also entitled to recover such additional costs from you. This clause is intended to be for the benefit of an enforceable by our debt collection agent under the Contract (Privacy) Act 1982.



- All goods remain the property of Weleda NZ Ltd until paid in full by the purchaser. Goods will not be despatched when accounts are overdue.
- Claims for damaged or loss of goods in transit should be made to the appropriate carrier. We will of course assist. Claims for damages, shortages or incorrect goods must be made within seven days of receipt.
- Return of incorrectly despatched goods must be made within one week of invoice/despatch date in order to qualify for a credit.
- Failure to meet payment terms may result in permanent withdrawal of credit.
- All prices are subject to change without notice.
- All accounts are operated at Weleda NZ Ltd's discretion. Accounts that do not exceed an annual spend of \$1,000 are no longer eligible for credit and the account will therefore be closed.
- Under no circumstances is Weleda NZ Ltd liable for any claim, action, demand, suit, loss, legal fee or other cost or expense of any kind whether directly or indirectly arisen from the use/inability to use any goods or services supplied by Weleda NZ Ltd.
- Pursuant to section 43 of the Consumer Guarantees Act 1993, that Act will not apply where the customer acquires or holds itself out as acquiring the goods and services for the purpose of business. Except to the extent that the Consumers Guarantee Act does apply, no warranties are given by Weleda NZ Ltd in respect of goods and services supplied whether in respect of quality, fitness for intended purpose, or otherwise and all warranties implied by law are expressly excluded.
- Weleda NZ Ltd may in its discretion accept goods returned in return for a credit and will not be bound to provide cash refund.
- Weleda NZ Ltd reserves the right to amend this contract to reflect variation in the Weleda NZ Ltd's contract Terms of Trade. Weleda NZ Ltd will advise the customers of those variations or any new contract Terms of Trade by notice in writing to the customers last known address in Weleda NZ Ltd's records. Any further orders placed by the customer for services or goods after receipt of the notice from Weleda NZ Ltd will constitute acceptance of the new contract Terms of Trade.
